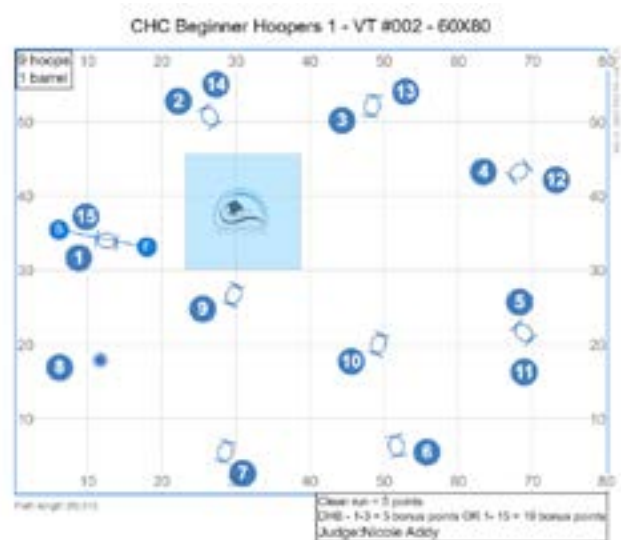
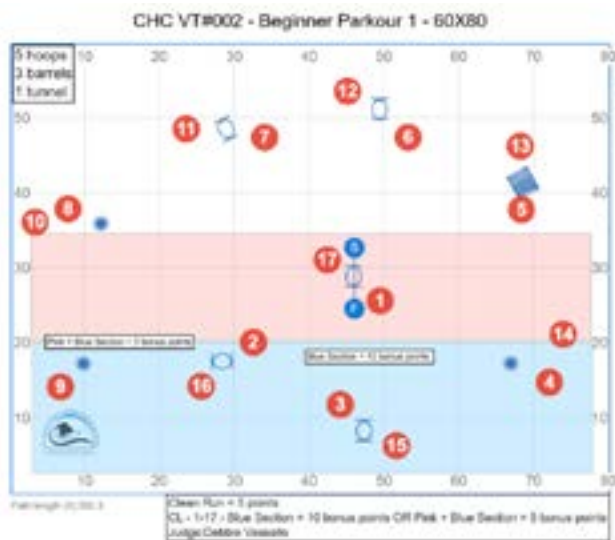
What is Hoopers?

I am excited to offer the first chance to run a hoopers style course in a fun match setting in Nova Scotia. Hoopers is a fun new sport that combines much of the excitement of agility but it is lower impact and has a greater emphasis on distance skills. Courses consist of hoops, short tunnels, barrels, and gates. There are no contacts, weaves, tight turns, or backsides allowed. The handler can choose to run with their dog, or handle from a designated handler box or challenge line for extra points.

We will be running a parkour style class, which is a course that involves all of the available obstacles (think of it like the hoopers equivalent to a standard class in agility). Dogs are divided into 3 height classes based on the measurement of their ulna to their elbow, however they all run the same course:

- 5 inches and under — small
- 5 to 7 inches — medium
- Over 7 inches — large

I will go over the rules in more detail during the briefing. Even if you have never tried hoopers before, you can sign up for a run (or two!) to do some obstacle familiarization to see if this is a sport you'd like to try. Fun Match Guidelines

VOLUNTEER LIST: Submission of your entry to this funmatch indicates agreement to perform a working position for the trial. An online spreadsheet will be posted where you can select your preferred working position. A volunteer grid will be posted at the match

PARKING AND CRATING: Crating will be from your car only. Please park on the left side of the road facing the barn (the other side of the road is on someone else's property). Please be mindful that you are not blocking anyone's driveway. Do not park any closer than the small garage beside the arena so as not to block the owner's driveway and also we must leave a clear path from the barn to the outdoor paddocks. Please try to park as close as you can so as many cars can get in this area as possible.

RING ENTRY: Enter through the main arena door, do not enter the stable. There will be a temporary fence with an in and out gate inside the arena. There will be a small space inside the arena where chairs can be setup, however no dogs are allowed inside except for those about to enter or those exiting the ring.

REWARDS: Toys and food will be allowed in the ring. Food should be delivered directly to your dog's mouth and not thrown on the ground. If you are throwing a toy please be mindful that you are not throwing it into equipment.

GENERAL NOTES: All dogs must be under control (i.e. penned, crated, or leashed) when not in the ring. This is a working horse farm, please keep your dogs away from the horses. If your dog is found to be harrasing any of the horses you will be asked to leave without refund. Please pick up after your dog. Please bring your own water. There will be a porta potty on site.

There will be no printed course copies, they will be emailed out the night before the trial, if you want a hard copy you will need to bring one with you.

I (we) agree that the club holding this event has the right to refuse this entry for cause which the organizing committee shall deem to be sufficient. In consideration of the acceptance of this entry, the holding of this event and the opportunity to have the dog participate or be judged, I (we) agree to hold the organizing committee, the organization which it represents, including its members, officers and directors, owners of premises upon which the event is held and their employees, harmless from any claim for loss of injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the parties aforementioned, or by the negligence or any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and same the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by the law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other person.
